MEMORANDUM OF UNDERSTANDING

FOR

THE COREY TINDALL MEMORIAL SPEECH & DEBATE FUND

This Memorandum of Understanding, dated as of December 2, 2011, between THE COREY TINDALL MEMORIAL SPEECH & DEBATE FUND, INC. (the "Corey Tindall Fund") and the ANCHORAGE SCHOOL DISTRICT (the "District") is entered into for the purpose of establishing the framework and guidelines for the award of funds donated by the Corey Tindall Fund to the District to: (a) support the South Anchorage High School Drama Debate & Forensics Team (the "DDF Team"), including, for example, to pay for DDF Team supplies, tournament and competition entry fees, and travel ("Team Support"); and (b) make awards to members of the DDF Team from time to time ("Individual Awards"):

- A. Annual Memorial Grant. The Corey Tindall Fund anticipates donating funds annually to the District on or before November 30 of each year. The funds donated will constitute the annual "Corey Tindall Memorial Grant" or the "Grant." At the time of the Grant, the Corey Tindall Fund may designate the amount of the Grant the Fund desires be applied to: (a) Team Support; and (b) Individual Awards. If the Corey Tindall Fund does not make any designation, the Awards Committee described in section B shall have discretion to determine the amount of funds to allocate to Team Support and Individual Awards; provided that, at least 20% of the annual Corey Tindall Memorial Grant shall be allocated to Individual Awards, with the balance to Team Support allocated in accordance with section C.
- B. Allocation of Funds. A committee comprised of the DDF Team head coach, the principal of South Anchorage High School, assistant principal Rodger Nicholls, Beverly Thornburg and a fifth person selected by the DDF Team head coach who is familiar with the DDF Team and its members (the "Awards Committee"), will determine: (a) the amount of that year's Corey Tindall Memorial Grant to allocate to Team Support and Individual Awards, if not designated by the Corey Tindall Fund; and (b) the amount of each Individual Award based on available funding; provided that, the Corey Tindall MVP Award shall be at least \$1,500 and each other Individual Award shall be at least \$500; and (c) the specific Individual Awards to fund in the event insufficient funding is received to make all awards identified in paragraphs D and E, below, in the minimum amounts. The minimum amounts may be increased in the discretion of the Awards Committee from time to time to maintain the minimum awards at meaningful levels. If a member of the Awards Committee is no longer willing or able to serve on the Committee, the DDF Team head coach, in consultation with the South Anchorage High School principal, shall select another person to serve on the Committee.

- C. **Team Support.** The Awards Committee will have discretion to determine the expenses to which Team Support will be applied; provided that the Awards Committee shall endeavor to use the Team Support to supplement and enhance the DDF team experience, by expanding competitive opportunities for participants, particularly through travel to tournaments within and without Alaska. The Corey Tindall Memorial Grant shall not be used to replace funding normally provided by the District, absent the prior written consent of the Corey Tindall Fund.
- D. The Corey Tindall MVP Award. The Corey Tindall MVP Award, made to recognize the most valuable member of the DDF Team each year, will be made to a DDF Team member selected by majority vote of the DDF Team coaches and all members of the DDF Team.
- E. **Other Individual Awards.** Other individual awards may also be awarded. The recipients of the following Individual Awards will be selected by the DDF Team coaches:
 - Outstanding Novice
 - Outstanding Interpreter
 - Outstanding Speaker
 - Outstanding Debater
 - The Kelly Horner Memorial
 - Outstanding Forensics Student

In selecting the recipients of the above awards in sections D and E, the DDF Team coaches shall consider the attributes described by the title of each award. Individual DDF Team members may receive more than one Individual Award. The District will provide the Corey Tindall Fund right of first refusal to present awards in each year during the term hereof and will provide notification of the timing of the awards presentation and an invitation to participate in the ceremony at least six (6) weeks in advance of the presentation in future years.

F. Certificate. Award certificates shall contain the following statement:

"This award is given in honor of Corey Tindall"

- G. Use of Awards. The Individual Awards shall be used for the purpose of paying education expenses at the school of the recipient's choosing or for paying other education-related expenses.
- H. Handling of Funds. All funds donated by the Corey Tindall Fund will be processed in accordance with District procedures and the Internal Revenue Code of 1986, as amended. Donations made by the Corey Tindall Fund may be co-mingled with the District general fund but shall be used solely for purposes of Team Support and Individual Awards.

I. Cost of Administration. The cost of award certificates may be paid from the Team Support funds. The District does not anticipate any other costs to administer the award of the Corey Tindall Memorial Grant. The District is not required to render any accounting to the Corey Tindall Fund, but will make available financial reporting including a summary and detailed listing of expenditures upon request.
